Course Description

This class is designed for students who will in all likelihood not have the opportunity to take many film courses. It is a fast but interesting (!) survey of American film from the silent days to the present. The course will cover the films listed below in terms of their cinematic technologies, their cultural contexts, their narrative forms, and their star/auteur status. These four categories will serve as the basis for a practical critical strategy for reading films.
