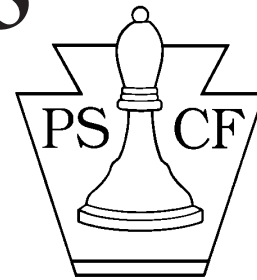

Premier - Open to those who are either unrated or rated under 1600

Prizes: (Guaranteed) 1st \$90, 2nd \$60, U1400 \$50, U1200 \$40, U1000 \$30. **Entry Fee:** \$25 by 7/27, \$35 later.

Trophies: 1st & 2nd, 1st & 2nd under 1400, 1st & 2nd under 1200, and 1st & 2nd under 1000.

Scholastic - Open to players in grades K to 12 who are either unrated or rated under 900
